The purpose of the COVID-19 Watch is to summarize the coronavirus surveillance and vaccine uptake in the City of Cleveland, Ohio. This report uses data available through April 22, 2023. Data on COVID-19 case demographics focus on the last four full weeks prior to publication (March 26 - April 22, 2023).

What Matters Most

- 1. Cleveland COVID-19 activity decreased during the month of April with an average 7-day incidence rate of 39 new cases per 100,000 residents. This is comparable to state-wide COVID-19 activity during the same time frame which, averaged a 7-day incidence rate of 19 new cases per 100,000 residents. As of April 22nd, all Ohio counties have a COVID-19 Community Level of "low". While COVID-19 continues to circulate in the community fewer people are experiencing severe illness or require hospitalization. At a low Community Level, CDC recommends that residents stay up-to-date with COVID-19 vaccines, including recommended booster doses.
- 2. 353 residents received their first COVID-19 vaccine during the month of March. As of March 28th, 57.9% of Cleveland residents have received any dose of a COVID-19 vaccine, 50.9% have completed their primary vaccination series, and 26.4% have received a booster dose. Appointments for adults and children can be made visiting gettheshot.coronavirus.gov.
- 3. The World Health Organization has elevated the Omicron subvariant XBB.1.16 as a variant of interest. This variant is responsible for an increasing percentage of new cases within our region. Like other Omicron subvariants it does not appear to be causing more severe illness than previous strains.







Figure 2. City of Cleveland COVID-19 Cases by Age (Mar 26, 2023 - Apr 22, 2023) (based on 592 cases)





Figure 3. COVID-19 Cases in City of Cleveland by Age (Mar 26, 2023 - Apr 22, 2023) (based on 592 cases)

Figure 4. City of Cleveland COVID-19 Cases by Gender (Mar 26, 2023 - Apr 22, 2023) (based on 594 cases)





Figure 5. COVID-19 Cases in City of Cleveland by Gender (Mar 26, 2023 - Apr 22, 2023) (based on 594 cases)

Figure 6. City of Cleveland COVID-19 Cases by Race (Mar 26, 2023 - Apr 22, 2023) (based on 544 cases)





Figure 7. COVID-19 Cases in City of Cleveland by Race (Mar 26, 2023 - Apr 22, 2023) (based on 544 cases)





Figure 9. COVID-19 Cases in City of Cleveland by Ethnicity (Mar 26, 2023 - Apr 22, 2023) (based on 594 cases)





% of Cleveland Residents Vaccinated per Age Group




% of Cleveland Residents Boosted by Age Group







% of Cleveland Residents Boosted per Race Population







Figure 11. City of Cleveland COVID-19 Hospitalizations by Demographics (Feb 15, 2020 - Apr 22, 2023) (based on 6,099 cases)













By Gender







MetaData

The Cuyahoga County numbers are approximate and have been populated using the DataOhio Portal.

This data report reflects the period starting from February 15, 2020 through April 22, 2023 for the City of Cleveland, Ohio.

Total Cases represent confirmed and probable cases.

Cleveland City data and Cuyahoga County data are compiled on April 25, 2023 using the DataOhio Portal.

Population and demographic data are from the US Census Bureau's 2020 estimates.

Data is preliminary and subject to change.

There may be a delay in reporting.

Data is reported by test date. If test date is unknown, the date a case is reported to Ohio Department of Health is used as a substitute for the test date. The number of cases can vary based on dates used for analysis.
